### **CLASS UPDATE FOR JUNE 2017**

Dear Class:

Please find below a summary of the Legal Team's most recent and upcoming efforts.

#### **I. Reassigned Cases**

Two of our class actions have been reassigned to another judge since the previous update:

1. The first suit is our class action lawsuit in federal court against Governor Snyder, the State of Michigan, and other governmental officials. This case, which was originally assigned to Judge John O'Meara, was filed in Federal District Court in Detroit, Michigan. **It is now assigned to Judge Judith Levy**, case number 15-14002.

2. The second suit is our class action lawsuit that has been filed against engineering companies, Lockwood, Andrews, and Newnam ("L.A.N.") and Veolia North America. This case, which was originally assigned to Judge John O'Meara, was filed in Federal District Court in Detroit, Michigan. **It is now assigned to Judge Judith Levy**, case number 16-11480.

#### **II. Summer Volunteers**

The Legal Team has recently gained new summer volunteers. They will be reaching out to class members to conduct interviews throughout the upcoming months.

Last month, the city of Flint approved a 1 year moratorium on tax liens that were to be placed on the mortgages of at least 8,000 Flint residents. The city plans to use this time to update and alter the ordinance that encouraged the tax liens.
